Sub : Revised residential jurisdiction for grant of admission to the wards of DAE employees in AEC Schools, Anushaktinagar from the Academic Year 2016-17.

The duly constituted committee to recommend the residential jurisdiction for grant of admission to the wards of DAE employees in AEC Schools, Anushaktinagar, Mumbai for the academic year 2016-17 has met on 28th and 30th January, 2016, and submitted its recommendations alongwith a revised residential jurisdiction. The said recommendations of the committee have been approved by the competent authority in AEES and are to be implemented in all AEC Schools, Anushaktinagar, while granting admission to the wards of DAE employees for the academic year 2016-17.

The revised residential jurisdiction for grant of admission to the wards of DAE employees in AEC Schools at Anushaktinagar is enclosed for ready reference of Heads of AEC Schools, Mumbai. It is also conveyed that the following factors should also be taken into account by Heads of AEC Schools, Anushaktinagar, while granting admission to the wards of DAE employees in AEC Schools, Anushaktinagar from the academic year 2016-17.

1. The wards of DAE employees residing in Old Manadala, Old TIFR and TMC attached to Anushaktinagar should be considered for grant of admission in AECS-5 instead of AECS-2.
2. The wards of DAE employees residing outside Anushaktinagar should be considered for grant of admission as per the availability of seats in the preferred schools. However, preference may be given to accommodate the wards of DAE employees who are residing within the vicinity of Anushaktinagar area viz. Mankhurd, Cheeta Camp, Pailpada, Trombay, Panjarapol etc., in AEC Schools closer to these areas. Nevertheless, the final decision to grant admission to the wards of DAE employees who are residing within the vicinity of Anushaktinagar area is delegated to the Chairman, Local Management Committee, Mumbai.
3. The wards of DAE employees availing the facility of Day-Care centers viz. ARWA and KILBIL have to be considered for grant of admission in AEC Schools, Anushaktinagar, based on their residential jurisdiction. Requests if any, being received from such parents seeking admission to their wards in AECS-2 or AECS-4 (although their residential jurisdiction is not covered under these two schools) may be considered by the Chairman, Local Management Committee, Mumbai subject to availability of seats. Before considering such cases, LMC should confirm that no application of DAE employee residing within that particular school(s) residential jurisdiction is pending for grant of admission to his/her ward.

All the Heads of AEC Schools, Anushaktinagar are therefore, advised to give strict compliance to the aforesaid revised guidelines while granting admission to the wards of DAE employees in AEC Schools, Anushaktinagar from the academic year 2016-17.
